

# CHS Swim Team Lane Fees

**Lane Fees** are what the team pays to St. Georges School for using their pool. We will begin practice on Thursday September 17<sup>th</sup> with our 2 week Trial Period. This is for all NON USS Swimmers ONLY. This will cost \$25 per swimmer. The first official day of regular practice for all swimmers is Thursday October 1st. It will cost \$50 per month per swimmer. Because the majority of the team will swim for 4 full months this year from October 1st – Jan. 29st, the total cost per swimmer will be \$200. If you are a USS Swimmer (a swimmer who swims for a competitive swim team year round outside of CHS), and your USS practice schedule allows it, you are expected to come to ONE CHS practice per week. You can come to up to 2 CHS practices per week and pay \$75 in lane fees total for the year. If you are a USS Swimmer and you cannot come to a CHS practice, you will not pay Lane Fees. All Non USS Swimmers will have to pay full Lane Fees. All Non USS State Qualifiers will have to pay an additional \$25 Lane Fees for the first 2 weeks in February.

Please select your payment plan below and make checks payable to the “CHS Swim Team”. Lane Fees are due the first official day of swim practice. If you do not have your Lane Fee with you on the first day of practice, or have paid it before hand, you will not be allowed to swim that day.

## Lane Fee Plans: (Please Circle what applies to you)

Trial Period Lane Fees, Due September 17<sup>th</sup>, (Non Refundable):  
For newcomers to the CHS Swim Team that are not quite sure if they will be staying and swimming on the team the entire season. Or for non USS Swimmers that want to get a jump start of their swimming fitness.  
Two Week Cost (9/17 – 9/30): \$25

Regular Lane Fees, Due October 1st, (Non Refundable):  
For returning swimmers to the CHS Swim Team that know FOR SURE they will be staying and swimming on the team the entire season. And for newcomers who decide to stay with the team after the Trial Period. If there is a financial need, this can be paid in two installments. Please talk to Nancy Overheim. Payment plan will be as follows: \$100 Due October 1st and \$100 Due December 1<sup>st</sup>.  
Four Month Cost (10/1 – 1/29): \$200

USS Lane Fees, Due October 1st, (Non Refundable):  
For USS swimmers that want to and can attend 1 or 2 practices a week with CHS.  
Entire Season Cost (10/1 – 2/10): \$75

State Lane Fees, Due February 1st, (Non Refundable):  
For all Non USS Swimmers that qualify for the TN HS State Swim Meet.  
Two Week Cost (2/1 – 2/10): \$25
